

WARWICKSHIRE BOYS TRIALS 2007

The Warwickshire Boys Trials will be played on Thursday 12th April 2007
at Purley Chase Golf Club, Ridge Lane, Nr. Nuneaton, Warwickshire CV10 0RB

CONDITIONS OF ENTRY

1. Qualifications:

To be eligible to enter, a player must :-

- (a) be under the age of 18 years at 00:00 hours on 1st January 2007
- (b) be in possession of a playing handicap at the date of entry as follows:
 - Under 14 : Maximum 15 handicap
 - Under 16 : Maximum 12 handicap
 - Under 18 : Maximum 9 handicap
- (c) have been born in Warwickshire or be a Junior Member of a Warwickshire Golf Club affiliated to the County Golf Union or be the son of a Full Member of an affiliated Warwickshire Golf Club - provided that they have not represented, or played in another County's Junior or Boys Championship, since 13th April 2006.

2. Conditions of Play:

- (a) The Trial shall be played as an 18 hole Gross Stableford.
- (b) The Winner will be the competitor who returns the highest Gross points over 18 holes. In the event of a tie for first place after 18 holes, the Winner will be decided on the highest gross points for the last 9, 6, 3, 2, 1 holes.
- (c) No caddies will be allowed, and players shall walk at all times during a stipulated round.

3. Prizes:

- (a) Vouchers will be awarded for 1st, 2nd, 3rd, 4th, and 5th Best Gross points, and the Best Nett points in each of the age categories of : Under 18, Under 16 and Under 14.
- (b) No competitor may receive more than one prize.
- (c) Prize Winners and all other competitors are expected to be present at the prizegiving.

4. Entry Applications:

- (a) It is a strict condition of entry that where a competitor will be under the age of 18 years on the date of the competition, a Parental Consent Form is completed and returned with the Entry Form.
- (b) Applications must only be made on the Entry Form, all cheques should be made payable to Warwickshire Union of Golf Clubs (or WUGC) and must be sent with your completed Entry Application Form and – where appropriate - a Parental Consent Form, together with a 1st class S.A.E. to :

- 5. After play all competitors are required to change from their on course attire into jackets and ties.
- 6. The Competition will be played in accordance with the Rules of Golf as approved by the Royal and Ancient Golf Club, and as supplemented by Local Rules.
- 7. Any questions arising as to qualifications, Rules of Golf or any other points will be considered by the Executive Committee of the WUGC whose decision will be final. The Committee reserve the right to limit the number of entries.
